Charged a \$100.00 per hour for consultation and care planning. Further charges are based on a fee for service or monthly rate depending on the scope of services requested.

#### **SERVICE PROVISIONS**

Services provided by the hour are charged at a minimum of 2 hours.

Holidays begin at midnight on Holiday. Time and one half the regular fee will be charged for the following holidays: New Year's Day; Memorial Day; Independence Day; Labor Day; Thanksgiving Day; Christmas Day  
Hours in excess of forty(40) in one week for an employee will be charged an overtime rate of one and one half the regular rate.

Weekends begin at midnight on Friday and continue through midnight on Sunday.

Clients will be billed at \$.405 or the current I.R.S. rate per mile for client errands done with the care provider's car.

*My Care At Home* agency will provide any information necessary to assist clients in filing for private and long term

care insurance. However, client is responsible for all payments of invoices received and is responsible for pursuing reimbursement from client's insurance.

Requested interviews and orientations will be charged at the regular hourly rate.

Late cancellations and Not Home / Not Found will be charged at one half the regular visit rate and one half of the assigned hours at the regular hourly rate.

Service charges are inclusive of withholding taxes, social security taxes, federal and state unemployment, workers' compensation, professional and general liability insurance and payroll expense. All payments are due upon receipt of invoice. Any payments that exceed 30 days will accrue a finance charge of 1.5% monthly, together with reasonable attorney and collection fees.
